SOUTHERN REVIEW showed speed off the rail, drew clear in early stretch and was under urging to remain clear to the wire. ALCANUDANCE chased the pace three wide around the turn but couldn't get to the winner while proving second best. DANNY'S PRAYER reserved off the pace, passed tired rivals for the show. CHARMED AFFAIR rated off the pace, tired in the drive. HE'S APPEALING pressed the early pace along the inside, chased the winner around the turn, then faltered. HISTORYOFASAINTE was not a factor.
