Footnotes

BLUE EYED SWEETIE set the pace racing off the rail into the stretch, then responded when set down for the drive and held sway. BESO GRANDE well placed racing off the rail, eased outside the leaders on the far turn, advanced to reach the attending position in the stretch and continued on gamely for the place while unable to get to the winner. MEDIA BIAS bumped by EVIL QUEEN at the start, stalked the pace along the rail, advanced to loom a threat in the stretch but but couldn't gain late while being edged for the place. SNOW TRIAL allowed to settle after breaking slowly, passed tired rivals while unable to keep pace with the top ones. DAISEY LEE stalked the pace three wide to nearing the stretch, then tired. LUNA GRANDE reserved off the pace, raced four wide around the far turn and faltered. STARSHIP CRYSTAL off slowly, was not a factor. EVIL QUEEN stumbled at the start bumping both MEDIA BIAS and GREATEST DREAM while recovering, saved ground to nearing the stretch, then dropped back. GREATEST DREAM was outrun after being bumped and steadied at the start. GINNY G tracked the leaders three wide to midway of the far turn, then faded.
