**Footnotes**

TEMO'S DREAM moved up on the backstretch to prompt the pace, gained a slim lead outside CINNAMON ROAD in the stretch, then lugged in at the eighth pole impeding that rival and prevailed while continuing to race erratically. CINNAMON ROAD set the pace along the inside into the stretch, then was steadied from inside at TEMO'S DREAM at the eighth pole and couldn't stay with that rival while clearly second best. QUIET EMARATI stalked the pace along the inside, angled outside the leaders on the far turn and tired in the drive. GRAND CASH reserved off the pace, raced in contention three wide around the far turn, then couldn't keep pace in the drive. LIVINGSTON STREET saved ground and faltered. POWERCHORD was not a factor. DON TELLADAGA threw his head at the start, tracked the pace to the far turn, then faded and was eased in the final eighth. Following a stewards inquiry and a claim of foul by the rider of CINNAMON ROAD, TEMO'S DREAM was disqualified and placed second for interference to that rival at the eighth pole.
