CUTE CONNIE raced with the pace three wide, moved to take over leaving the turn, then drifted to the rail nearing the eighth pole and drew clear. LADY IRENE tracked the pace four wide into the stretch, then closed to be up for the place while no match for the winner. BACK BAY BEA vied for the lead along the inside into the stretch,checked in behind CUTE CONNIE nearing the eighth pole, then couldn't keep pace with that rival while being edged for the place. HEAVENLY POWDER vied for the lead between horses to nearing the stretch and tired. SALVESTER reserved in striking position racing along the rail, faltered in the drive. l'LLCALLYOUBACK was not a factor. The rider of BACK BAY BEA lodged an objection against the rider of CUTE CONNIE for alleged interference nearing the eighth pole. The claim of foul was not allowed.
