MOREAPPLAUSEPLEASE tracked the pace three wide, rallied to take over in the stretch, then drifted in a bit late and prevailed. HEAVEN'S AWESOME reserved off the pace, advanced along the inside to reach contention, then was steadied from inside MOREAPPLAUSEPLEASE in deep stretch and proved second best. MONEYMaking broke a step slowly, chased the pace, made a run to try DOCTOR GARRETT on the turn and into the stretch, then tired. DOCTOR GARRETT off a step slowly, sprinted to a clear lead along the inside, responded when challenged by MONEYMaking on the turn, maintained a slim advantage into the stretch, then tired. RAINBOW CRUISE well placed while saving ground, had no response when asked. OCEAN CRUISE raced three wide and failed to menace. CHILI PALMER was outrun. TRUTH OR DARE was no factor while racing five wide. DODGEM rated off the pace, faltered leaving the turn. JUMBO JUMBO raced four wide and faded. The rider of HEAVEN'S AWESOME lodged an objection against the rider of MOREAPPLAUSEPLEASE for alleged interference in deep stretch. The claim of foul was not allowed.
