Footnotes

RO MEGA was rated on a short lead while kept slightly removed from the inside, held off challenges from Sicky Nicky and Peaceadaaction when roused turning for home, another from Dream Appeal approaching midstretch and edged well clear at the end. DREAM APPEAL forced the winner's early pace while saving ground, dropped back a bit leaving the turn, eased out to split rivals with his bid nearing midstretch and hung late. SICKY NICKY stalked the pace while racing three wide from the outset, remained close up to midstretch and tired. KAKA saved ground on the turn and had no rally. PEACEADACTION broke a step slow, rushed up between horses and had to steady briefly in traffic midway the backstretch, moved four wide to join the leaders entering the stretch, tired badly and was drifting steadily while easing up near the wire. BUBBA AND TEE broke slow, moved to contention once recovering on the rail, had to take up sharply along the inside midway the backstretch and was never a factor thereafter. JOHARLINGTON raced wide and stopped.
