Footnotes

UNTUTTTABLE AFFAIR set the pace off the rail into the stretch, then drew off while being kept to the task. VICTORY CAFE chased the winner three wide into the stretch but was no match for that rival while best of the others. DREW outrun early, passed tired rivals for the show. VEER unhurried early, angled out for the drive and improved his position without threatening. INDY KINGS DANCER bumped with NORTHERN ACADEMY on the first turn, then steadied to avoid running up on the leader midway of the first turn, eased out to chase the pace four wide around the far turn and tired. NORTHERN ACADEMY rated off the pace, was bumped by INDY KINGS DANCER on the first turn, raced three wide around the far turn and faltered. PAPA MIA was never a factor. ECLIPSEONE well placed into the far turn, faded. JAZZAHOLIC chased the pace to midway of the far turn, then had nothing left and was eased in the final eighth.
