SMART CITY DOC bumped with DREAMING PRAYERS at the start, pressed the pace outside SARAFRAS, took over from that rival at the eighth pole, then edged away under urging. SARAFRAS set the pace under pressure along the inside into the stretch, then weakened. PRIZE FEVER bumped with DREAMING PRAYERS at the start, chased the pace around the turn and gave way. MY ROLEX tired from good position. FIERY GIRL was never a threat after throwing her head and being steadied at the start. FULL N SASSY was not a factor. SUPERSONIC BEAUTY raced three wide and faltered. DREAMING PRAYERS jostled between rivals at the start, chased the pace three wide around the turn and faded. FROSTY THUNDER was through early.
