STREET MAGIC rated off the pace, raced four wide around the turn, rallied to take over at the top of the stretch, then drew off. OUR GOLDEN SNITCH pressed the early pace outside SUNRISE RIDGE, couldn't stay with that rival on the turn, made a run to reach near even terms for command at the top of the stretch but was no match for the winner while clearly best of the rest. SUNRISE RIDGE off slowly, moved up quickly to show speed along the inside, made the pace to the top of the stretch, then was tiring when checked from inside OUR GOLDEN SNITCH approaching the eighth pole. RHYTHM OF MY SOUL reserved after stumbling at the start, drifted out leaving the turn and faltered. AGUANILE chased the pace three wide to nearing the stretch, then faded. WILLA BELLA was done early. THE RIDER OF SUNRISE RIDGE LODGED AN OBJECTION AGAINST THE RIDER OF OUR GOLDEN SNITCH FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
