EXUBERANT SONG showed speed off the rail, edged away from ALYSON'S APPLE on the turn, responded when challenged again by that rival in early stretch, then dueled with that one to the wire and prevailed. ALYSON'S APPLE showed speed along the rail, dropped back racing around the turn, came on again to engage EXUBERANT SONG again in early stretch, then dueled in close quarters along the rail with that rival to deep stretch and was edged to the wire. YES HE'S INNOCENT reserved along the inside after breaking a step slowly, eased out for the stretch run and rallied for the show. GORLOCK off a step slowly, chased the leaders into the stretch and gave way. LEFT YOU BEHIND was no factor while racing three wide. CASSIDYS JET well placed early, raced three wide around the turn and tired. MY FRIEND RALPH was outrun. SPARTAN GENERAL steadied from tight quarters on the backstretch and was never a threat. THE RIDER AND TRAINER OF ALYSON'S APPLE LODGED OBJECTIONS AGAINST THE RIDER OF EXUBERANT SONG FOR ALLEGED INTERFERENCE IN THE STRETCH. THE CLAIMS OF FOUL WERE NOT ALLOWED.
