HANNA'SLUCKYSTAR chased the pace three wide into the stretch, then rallied to be up late. SECOND TIME pressed the pace outside CLASSY AND SERENE, moved to take over from that rival on the turn and opened a clear lead but couldn't resist the winner late. MAURA'S IMAGE chased the pace along the inside, angled out leaving the turn, was steadied to avoid CLASSY AND SERENE at the top of the stretch, then rallied to just miss the place. FREEBIE'S SISTER unhurried after breaking awkwardly, swung wide for the stretch run and closed with a belated rally. VAZ HOPE saved ground and failed to menace. CLASSY AND SERENE set the pace under pressure along the inside into the turn, then was fading when angled out at the top of the stretch. THE TRAINER OF MAURA'S IMAGE LODGED AN OBJECTION AGAINST THE RIDER OF HANNA'SLUCKYSTAR FOR ALLEGED INTERFERENCE AT THE TOP OF THE STRETCH. THE CLAIM OF FOUL WAS NOT ALLOWED.
