MR. SLUGGO chased the pace through the three quarters, gained command in the early stretch and just lasted at the wire. SWEETSOUTHERNMAN was unhurried early and rallied throughout the stretch run. CRITICAL STING offered his best foot too late. FATHER LUCEY raced even throughout and gave bid. KINGS COVE set the pace through the three quarters and was used up after. CASH ADVANCE was in good position at the front of the pack and stopped going into the stretch.
