SHE'SFROM DELAWARE vied for the lead outside JOYFUL BIRD, drew away around the turn, then was fully extended to hold IMELDA OH safe. The latter, reserved off the pace after breaking slowly, swung out for the stretch run and rallied to be up for the place. HOLY LAND rated off the pace, raced four wide around the turn and rallied while being edged for the place. SEA BIRDIE unhurried early, closed some ground without threatening. STORMY DEEDS tracked the pace four wide, advanced to reach the attending position racing into the stretch, then tired. HOLIDAY BLAZE tracked the pace into the stretch and faltered. BLUSHING TIGER off slowly, failed to menace. TINKERBUCK chased the pace three wide into the stretch, then had nothing left. MEMORABLE MICHELLE was not a factor. JOYFUL BIRD vied for the lead along the rail into the turn, then faded. BACK TO REALITY was done early. JACKIE B GOOD through after a half mile after lunging at the start, eased in the stretch run and was vanned off.
