GIBSON COUNTY LINE vied for the lead outside FATHERS HONOR around the turn, then drew off under urging. THOMASQUITO unhurried after breaking poorly, raced three wide around the turn and closed to be up for the place while no threat to the winner. FATHERS HONOR vied for the lead along the inside to nearing the top of the stretch, angled out and gave way. TURBO CAT off slowly, saved ground and failed to menace. CZARDOM tracked the pace off the rail into the stretch and tired. DOC SMILES showed brief speed along the rail, tracked the leaders around the turn, then faltered. I'MANOTHERBROTHER reserved off the pace, faded leaving the turn.
