UNTUTTTABLE AFFAIR reserved off the pace, came through along the inside leaving the far turn, eased outside SOMES SOUND, rallied to catch that rival inside the eighth pole and edged away. FIVE STAR JOHN allowed to settle, raced three wide around the far turn and rallied to be up for the place. SOMES SOUND set the pace under pressure along the rail, opened a clear lead on the far turn, made the pace to past the eighth pole and was outfinished. EASTERN SEABOARD well placed racing along the rail, advanced to loom a threat in the stretch, then flattened out. HO HO HO rated off the pace, advanced to reach contention in the stretch but couldn't gain late. HELLO MECKE failed to menace after breaking slowly. BARLEY SUGAR off slowly, was never a factor. SMOKE'N CHEROKEE was never a threat after breaking slowly. LORD ABOUNDING pressed the pace outside SOMES SOUND into the far turn and tired. FLAMINGO RED was outrun and vanned off after the finish.
