ANDRALUCY unhurried after clipping heels entering the first turn, moved up into contention down the backstretch, angled to the outside for the stretch run, then rallied to take over at the sixteenth pole and edged away. GUIGUE'S MIRACLE reserved early, rallied four wide into the stretch, moved to take over at the eighth pole but couldn't stay with the winner late while continuing on with good courage for the place. WEATHER PERMITTING outrun after breaking slowly, rushed up on the backstretch to vie for the lead three wide, was outmoved a bit on the far turn, then came back on to engage the leaders in the stretch and gave way. ABENI vied for the lead along the inside, then drifted out in the stretch impeding KIZUNA and tired. KIZUNA stalked the pace along the inside, was steadied at the top of the stretch, then checked when unable to get through inside ABENI at the eighth pole, came outside that rival and was steadied when that rival came out bumping her in the stretch, then faltered. COUNT ON SUMMER vied for the lead outside ABENI into the stretch, then had nothing left. FELICITATE saved ground to no avail. AMERICAN PROUD vied for the lead four wide into the far turn and faded. FOLLOWING A STEWARDS INQUIRY AND A CLAIM OF FOUL BY THE RIDER OF KIZUNA, ABENI WAS DISQUALIFIED AND PLACED FIFTH FOR INTERFERENCE TO THAT RIVAL IN THE STRETCH.
