**Footnotes**

MINER'S TUNE reserved off the pace, angled to the outside leaving the far turn, then rallied to be just up at the wire. CELESTIAL KITTEN stalked the pace three wide, rallied to gain a slim lead at the eighth pole, then just failed to last. TOPAZIO chased the pace off the rail, made a run to try the leaders through the final eighth but was edged to the wire. CHANNEL ELEVEN set the pace along the rail into the stretch, then was weakening when steadied late. LEXINGTON PEARL allowed to settle, closed ground late without threatening. STARSHIP JODI rated off the pace, raced three wide around the far turn and had no response in the drive. ROLLBABY off slowly, was never a factor. VERSO A VERSO steadied along the rail nearing the wire the first time, stalked the pace into the far turn and faltered. THE RIDER OF CHANNEL ELEVEN LODGED AN OBJECTION AGAINST THE RIDER OF TOPAZIO FOR ALLEGED INTERFERENCE INSIDE THE SIXTEENTH POLE. THE CLAIM OF FOUL WAS NOT ALLOWED.
