MIZ UNITED STATES well handled while setting the pace along the inside, drew clear in early stretch, then was all out to hold off REGALLY APPEALING. The latter, in hand while stalking the pace, was outmoved by the winner in early stretch, then was gaining on that rival at the wire. PLETTENBERG BAY tracked the pace three wide into the stretch and tired. COOLBYTHEPOOL a bit rank under restraint racing into the first turn, failed to threaten. SABRE DANCE reserved four wide after breaking slowly, faltered. ADVANTAGE, off slowly, checked when FAST DISPERSAL broke down on the far turn and was not a factor. PICCA PEPPER faded while saving ground. FAST DISPERSAL well placed, broke down on the far turn and unseated her rider.
