Footnotes

ANDYCAT unhurried while saving ground into the stretch, angled outside the leaders, then rallied to be up late. INDY KINGS DANCER stalked the pace, angled outside the leaders at the top of the stretch, moved to gain a slim lead outside COMPRISE at the eighth pole, then came in under right-handed pressure impeding COMPRISE in deep stretch while being outfinished by the winner. COMPRISE unhurried early, rallied outside CEE T CEE TWO to gain a slim lead in early stretch, drifted in impeding that rival, then was vying for the lead when forced to check from inside INDY KINGS DANCER in deep stretch and failed to recover. CEE T CEE TWO reserved early, rallied three wide to gain a slim lead entering the stretch, then was steadied when forced in by COMPRISE in early stretch and tired. ENGADIN chased the leaders while wide into the first turn, was angled in and moved up to vie for the lead along the rail into the far turn, was steadied from close quarters on the far turn, then steadied again when CEE T CEE TWO was forced in front of him in early stretch and gave way. PAPA MIA rated off the pace after being checked from tight quarters on the first turn, saved ground around the far turn and faltered. RAYO DE LUZ steadied from tight quarters on the first turn and was through after six furlongs. DIGNIFIED ESSENCE was vying for the lead when steadied and angled inside SNUCK ON BY on the backstretch, moved back up to contest the pace around the far turn, then faded. SNUCK ON BY was vying for the lead when he drifted out racing down the backstretch, stopped abruptly entering the far turn and was eased in the stretch run. Following a stewards inquiry into the incidents on the first turn and through the stretch run, COMPRISE was disqualified and placed fourth for interference to both CEE T CEE TWO and ENGADIN in early stretch, INDY KINGS DANCER was disqualified and placed fifth for interference to COMPRISE in deep stretch.
