### Footnotes

CINNAMON ROAD sprinted to a clear lead racing down the backstretch, made the pace along the inside into the stretch, then drew off when roused. GRAND CASH outrun early, raced four wide around the far turn and closed to prove second best while no match for the winner. DECAF AGAIN rated off the pace, raced three wide around the far turn and passed tired rivals for the show. LEATHER tracked the pace into the far turn and tired. PICHIMENTA was not a factor. MANDATUM chased the winner to nearing the stretch, then faltered and was eased in the final eighth. DEALING LUCKY chased the leaders three wide into the far turn, faded and was eased in the stretch run. BEN AND DOUG was outrun and eased leaving the far turn.
