**Footnotes**

PRESSURE stalked the pace, rallied to reach near even terms for command at the quarter pole, was bumped by SCORPION STRIKE in early stretch, was dueling with that rival when bumped again in deep stretch and prevailed. SCORPION STRIKE rated off the pace, rallied to gain a slim lead at the quarter pole, came in and bumped PRESSURE in early stretch, was dueling for the lead when he came in to bump that rival again in deep stretch and was edged to the wire. SOMETHING GAINED set the pace along the rail to nearing the quarter pole, then tired. EL TABRAWY saved ground and couldn't keep pace with the top ones. ONE NIGHT ALONE tracked the pace four wide to nearing the stretch, then tired. I'M DANCING TOO raced three wide and faltered. TRADER JOHN was not a factor. HOLDING THE CHECK was outrun. SUPER ROCKET MAN chased the pace into the far turn, then tired. The rider of SCORPION STRIKE lodged an objection against the rider of PRESSURE for alleged interference in the stretch. The claim of foul was not allowed.
