Footnotes

DISTINCTION LADY A chased the pace three wide into the stretch, then rallied to be up late while holding off RAPID DISTINCTION. The latter, reserved off the pace after being steadied at the start, swung out for the stretch run and rallied to just miss. SUNRISE RIDGE showed speed off the rail, edged clear on the turn, made the pace to deep stretch and yielded. ANTIA saved ground and failed to menace. RHYTHM OF MY SOUL chased the pace four wide around the turn and gave way. LA RANCHERA chased the pace, eased to the inside on the turn to continue chasing the leader into the stretch, then tired.
