SNOW TRIAL rated off the pace, rallied for the place while being outfinished by the winner. MAX SPEED showed speed along the inside to nearing the sixteenth pole and weakened. DEVILISH LADY chased the pace off the rail to inside the eighth pole, then tired. AMAZING chased the pace along the rail around the turn and faltered.
