WYATT'S WOMEN reserved along the inside, angled out leaving the turn, rallied to gain the lead at the eighth pole, then drew clear. SUAVE ROYALTY chased the pace three wide, moved to take over leaving the turn, made the pace into the stretch but couldn't stay with the winner in the final eighth. MARGARET SMILE unhurried early, advanced to reach contention in the stretch but couldn't sustain her bid. FREEDOM AFLEET rated off the pace after being caught in tight on the backstretch, gave way in the drive. MEADOW TOUCH was never a threat after breaking a step slowly. BEA D J CODE chased the pace four wide into the turn and tired. CLASSIE HENNESSY pressed the pace along the rail to midway of the turn, then faltered. GIRL GLITTER showed speed off the rail to nearing the stretch and faded. The rider of FREEDOM AFLEET lodged an objection against the rider of SUAVE ROYALTY for alleged interference on the backstretch. The claim of foul was not allowed.
