Footnotes

INDIRECTLY A. P. chased the pace along the rail, was bumped by HOWELLING WIND at the eighth pole and his rider lost his whip soon after, then edged away under a strong hand ride. HOWELLING WIND showed speed off the rail, came in and bumped INDIRECTLY A. P. at the eighth pole, then couldn't stay with that rival while clearly second best. LORD CHELSIE broke slowly, was tracking the pace when checked nearing the end of the backstretch, continued to track the leaders into the stretch, then tired. BEST TRIP off slowly, steadied in behind LORD CHELSIE on the turn and failed to menace. SINGAPORE THUNDER rated off the pace, raced three wide around the turn and faltered. A'INTYOULDREAMIN was done early. COUNTY SLIP trailed after breaking a step slowly.
