TWAS ALL A DREAM unhurried early, angled out for the drive and closed to be up for the place while no match for the winner. RUTH'S MICK set the pace along the inside into the stretch, then gave way. UP 'N UP tracked the pace to nearing the stretch, then tired. BLUSHING TIGER was no factor while racing four wide. DANCIN SAMBA off slowly, raced three wide and faltered.
