CINNAMON ROAD set the pace off the rail, drew well clear in the stretch, then was fully extended to remain clear to the wire. WINGEDLIE prompted the pace three wide, was outmoved by CINNAMON ROAD into the stretch but continued on with good courage to prove second best. OFFICER'SGENTLEMAN raced with the pace four wide to the far turn, then tired. BAY OF WICKLOW was never a factor. AUTHORITY RULES rated off the pace, took a bad step on the first turn, was pulled up and vanned off.
