SCOTTYS PISTOL reserved racing off the rail, rallied to catch RUSTY CHARLIE inside the sixteenth pole and won going away. RUSTY CHARLIE showed speed along the inside, drew clear in the stretch but couldn't match strides with the winner late. NEW CROWN allowed to settle, rallied while drifting out through the stretch to be up for the show. PHOENIX HOTEL chased the pace along the rail into the stretch, then gave way. RAPID RATE chased the pace around the turn and tired. GHOSTSONG was chasing the pace when steadied from between rivals soon after entering the turn and failed to recover. SPIDERMANDATE was never a threat after breaking poorly. TIGERGLIDER saved ground and faltered. FROLIC ON HOME steadied at the start, moved up to chase the pace three wide around the turn and faded. TEN GOALS was outrun. RUNNING ON CLOUDS was through early.
