RIOJANO asked for some run early to maintain forward position, second flight in the turn inside, steadied, lacked room late in the turn, moved out, roused, powered by leader to be well clear. FIRE FALLS did not break with the field, remained back for three furlongs, advanced in some traffic late in the turn, steered out for the drive, closed well to be in time for the place. OUR MR. BUD in the second group while off the inside, went after the leader turning for home, gained the advantage soon after, got clear, no match for the winner late, caught for place in the waning strides. RADICCHIO evenly paced while saving ground off the pace, moved out a bit for the drive, lacked a winning kick. CASTLE LEOD brushed at the start, four wide through the turn when off the pace, improved position slightly while never a serious threat. CALLEJERO made little impact after racing in some traffic through the turn. GOOD BOY DADDY stumbled badly at the start, trailed for a half, passed tiring rivals. SIPPEWISSETT never menaced. TOP DOG settled early, had nothing for the drive. REGGAE MAN brushed at the start, soon got clear, set the pace for three furlongs then gave way when headed entering the stretch. ENOCHI backed up through the stretch. LATENT DANGER five wide through the turn, was always outrun.
