BEST OF THE REST, bumped at the start, set the pace, responded when challenged and was all out to prevail. SMUGGLER'S PRIZE, reserved and saving ground, steadied on the far turn, advanced to challenge for the lead in midstretch but couldn't stay with the winner late. WICAPI, allowed to settle, rallied four wide on the far turn to reach the leader, then weakened. LAUGHING DAN, bumped at the start, stalked the pace into the far turn and faltered. RELIC RHYTHM showed nothing.
