SMILIN' N BLUSHING outrun early, rallied along the outside to take over entering the far turn, angled in while drawing clear soon after entering the turn contributing to crowding, then was all out to last over JENNASIETTA. The latter, unhurried early, raced three wide on the far turn, angled out in the stretch and closed well for the place. DIANA MY LOVE reserved off the pace, advanced four wide around the far turn to reach the attending position in the stretch but didn't do enough late. LAUREL LIGHT outrun early, passed tired rivals without threatening. REVE RUSSE well placed racing between horses, was steadied in the stretch when NIZY'S LIZZIE drifted in front of her and failed to recover. NIZY'S LIZZIE rated off the pace, advanced three wide to join the leaders racing down the backstretch, bumped with REGAL COUNTESS leaving the backstretch, then bumped again with that rival and steadied inside SMILIN' N BLUSHING soon after, continued on well into the stretch, then drifted in front of REVE RUSSE and tired. FRENCH MADAM allowed to settle, raced three wide on the far turn and had no response in the drive. JELLY FISH vied for the lead along the inside to the far turn, then faltered. REGAL COUNTESS vied for the lead outside JELLY FISH, then was bumped by NIZY'S LIZZIE and taken up from tight quarters soon after entering the far turn, then faded. SIMPLY RED showed early foot along the inside and stopped. Following an objection by the rider of NIZY'S LIZZIE against the rider of SMILIN' N BLUSHING for interference soon after entering the far turn, SMILIN' N BLUSHING was disqualified and placed ninth for interference to both NIZY'S

LIZZIE and REGAL COUNTESS.
