CAIXA ELETRONICA chased the pace, moved to take over soon after entering the turn, then drew away when set down for the drive. JAMES WILFRED unhurried early, saved ground into the stretch and closed to be up for the place while no match for the winner. B L'S TSUMANI showed early foot, raced three wide around the turn and didn't do enough late. FLIGHT TO EDEN chased the pace along the inside around the turn and tired. SEA MOUNT showed speed three wide into the turn, then couldn't stay with the winner and faltered in the drive. MOCORETA (URU) off slowly, steadied twice on the backstretch and was not a factor. MACHO GRANDE tracked the pace into the turn and faded.
