MY PREFERRED dueled for the lead along the rail to deep stretch and edged BON BON PRINCESS for the place while being outfinished by the winner. BON BON PRINCESS stumbled at the start, dueled for the lead outside MY PREFERRED to deep stretch and just missed the place while unable to hold off the winner. GREAT ACTRESS chased the pace into the stretch and lacked a late response. PONDSIDE up close early, raced three wide on the turn and tired. DAYLIGHT TIME was outrun.
