### Footnotes

THANK U PHILIPPE in tight at the start, raced off the pace in the two path, began to advance while along the rail second turn, continued inside, up in time.  
 PRIMARY WITNESS bothered at the start, raced well back and outside, advanced in the four path when roused late in the final turn, bid, outkicked late.  
 UNBRIDLED HEAT behind the pace two path, chased the leader through the final turn and into the lane, brief bid between rivals a furlong out, could not match strides with the top two late. SWAGGER JACK bumped at the start, recovered to race forwardly, took over, long lead into and through the second turn, continued to maintain a sizeable advantage into the lane, fell apart the final furlong. RIVERSRUNRYLEE cleared from the outside first turn, showed the way onto backstretch, relinquished the advantage before a half, faded. HIGH LEVEL JEFF broke out to set off a chain reaction of interference, settled in the second flight, backed up after six furlongs.
