**Footnotes**

BAD DEBT reserved off the pace, was racing three wide when caught in traffic on the far turn, found room and rallied to gain the lead at the sixteenth pole, then was fully extended to prevail. PICOOU outrun after breaking slowly, rallied between horses in the drive to be up for the place. ROMAN TIGER rated off the pace, rallied three wide to take over in early stretch, then drifted out impeding MIMITO BOY nearing the sixteenth pole and weakened. LIVINGSTON STREET outrun while saving ground, rallied along the hedge to loom a threat in midstretch but didn't do enough late. SLEWS ANSWER stalked the pace along the inside, eased out and moved into the attending position in the stretch, then gave way. MIMITO BOY well placed along the inside, angled out and made a run to loom a threat in midstretch, then steadied when ROMAN TIGER drifted in front of him nearing the sixteenth pole and failed to recover. STAY RED failed to menace. TANNERSVILLE stalked the pace three wide to nearing the stretch, then tired. STAR OF SARAVA prompted the pace outside OLIGARCH into the stretch and faltered. SCOTTISH COAST unhurried after breaking slowly, advanced five wide on the far turn to reach contention, then

faded in the drive. OLIGARCH set the pace along the hedge into the stretch, then had nothing left. BLACK SCORPION tracked the pace four wide into the far turn, then stopped. FOLLOWING A STEWARDS INQUIRY, ROMAN TIGER WAS DISQUALIFIED AND PLACED SIXTH FOR INTERFERENCE TO MIMITO BOY IN THE STRETCH.
