SWEEP MACHINE in hand while disputing the early pace, shook loose on the turn and was never threaten while in hand in the late stages. MAGNET LADY raced well back early, got through along the rail at the quarter pole and finished willingly. HALO ESKIMO failed to threaten with a mild four wide move on the turn. OUT OF SWEETS battled with the winner along the backstretch and faded on the turn. COUNTESS OF MINE saved ground and tired. BETH'S APPEAL checked at the start and was never close thereafter. SILVER LACES was outrun after breaking slowly. Post time was delayed 11 minutes when the rider of BETH'S APPEAL was injured behind the gate prior to the start.
