Footnotes

COMEONGAL tracked the pace, angled three wide on the far turn, rallied to gain the lead at the eighth pole and edged away under pressure. MYSTERIOUS LIGHT set the pace along the inside to midstretch, then couldn't stay with the winner while edging BRIJETTA LIGHT for the place. The latter, prompted the pace outside MYSTERIOUS LIGHT, made a run at the lead in the stretch but was outfinished. VOODOO FEVER unhurried early, passed tired rivals without threatening. SAINTLY SUE stalked the pace three wide into the stretch, then tired and drifted out late. REGAL APPROACH was caught in tight along the rail racing into the first turn, saved ground into the far turn, angled out and was never a factor. MORALAP was outrun. MORTGAGE THE HOUSE saved ground and faltered. TUTTLE CREEK was through after a half mile. TRIUMPH ARCH raced three wide and faded.
