MAJESTIC MOOD rallied along the outside to take over entering the far turn, then drew clear under urging. BACKTOTHEBOOKS chased the pace, was steadied when caught in tight entering the far turn, angled out for the drive and closed to be up for the place. D J K STORM well placed while saving ground, had no late response. RUM RASIN chased the pace, came out a bit entering the far turn, then weakened in the drive. MARINGRI was outrun. JANE'S HURRICANE rated off the pace, was checked when caught in tight entering the far turn and tired. MONEY FOR MAUI set the pace along the rail, then faded in the drive and returned lame. The rider of BACKTOTHEBOOKS lodged an objection against the rider of MAJESTIC MOOD for alleged interference entering the far turn. The claim of foul was not allowed.
