Footnotes

IRISH COVE rated off the pace, altered course to the outside for racing room in early stretch, then rallied to be up late. FLORIDA STRAITS tracked the pace, rallied and split rivals to gain the lead inside the eighth pole but couldn't stay with the winner late. GIVE ME A SMOOCH reserved off the pace, raced three wide into the stretch, made a run outside FAPPIES FOR CHANCE to reach even terms for command at the eighth pole, then weakened. FAPPIES FOR CHANCE stalked the pace, made a run at the leaders in early stretch, then was steadied from close quarters at the eighth pole and gave way. DANICA failed to menace. AWESOME FROLIC outran after she dwelt at the start, saved ground, then was steadied when unable to get through inside DANICA in the stretch and never threatened. DAZZLING PRINCESS prompted the pace outside RED PRIDE, moved to gain a slim lead in the stretch, then tired. CRISTINA'S DIAMOND was not a factor. RED PRIDE set the pace along the inside into the stretch and faltered. FLUFFY'S GIRL chased the pace for a half mile, then faded. The rider of FAPPIES FOR CHANCE lodged an objection against the rider of GIVE ME A SMOOCH for alleged interference in the stretch. The claim of foul was not allowed.
