SAINT PETE pressed the pace along the rail into the stretch, then edged away under urging. STARSHIP SULU showed speed off the rail, then drifted out on the turn while maintaining a slim advantage to the eighth pole, then weakened. ADJOURNMENT rated off the pace after lunging at the start, closed to be up for the show while no threat to the top ones. NOTIMETOKILL chased the pace along the inside around the turn, then tired. FOLLOW THE RHYTHM failed to menace after being steadied from tight quarters in the early going. VALTER chased the pace off the rail around the turn and faltered. RED ZONE FLYER off slowly, was outrun. DEFENSE MODE well placed early, faded.
