Footnotes

RUSSIAN NOTE bumped with DEED at the start, then was saving ground when checked in behind rivals on the far turn, rallied belatedly, angled out in the drive to take over a sixteenth out and edged away under pressure. WITH ESSENCE tracked the speed on the hedge, took over briefly in the drive and gave way. DEED stumbled and bumped with RUSSIAN NOTE at the start, allowed to settle, was steadied when caught in tight soon after entering the far turn, four wide into the stretch, then rallied to gain the show. PENNANT DANCER in good position four wide, offered a mild rally. CADET NURSE well place along the hedge then steadied between horses in the drive. BLUESPEEDWHITELITE in the middle of the pace, was steadied entering the far turn, then checked when caught in behind rivals in early stretch and lacked the needed late response. PROSPECTIVE MISS void of early speed after being steadied

at the start, five deep around the far turn, failed to menace. NO BADGE chased the speed off the hedge and weakened. BECKY'S SKIRT passed tiring rivals after breaking slowly. OLIVIA'S AFFAIR made the pace while saving ground and tired in deep stretch. RARE TREASURE stalked the pace, three wide and faltered. ATTICUS'S WOMAN showed brief foot. The rider of CADET NURSE claimed foul against the rider of WITH ESSENCE for alleged interference in the stretch. The claim was not allowed.
