

## **Footnotes**

MUSKETIER (GER) stalked the pace along the hedge, slipped through inside GONDORF at the top of the stretch to take over, then was fully extended to prevail. SIMMARD reserved while racing three wide, made a run three wide to reach near even terms for command at the quarter pole, was outmoved by MUSKETIER in early stretch but continued on gamely and was coming back on that rival at the wire. WINCHESTER unhurried for a mile, circled rivals four wide around the final turn to loom a threat entering the stretch but didn't do enough late. CENTER DIVIDER stalked the leaders into the stretch the final time but had no late response. GONDORF set the pace racing off the hedge, responded when challenged by SCOTTISH COAST racing into the clubhouse turn, vied with that rival into the far turn, edged away from that one midway of that turn, then gave way in the drive. LIVINGSTON STREET failed to menace. ASTRAL THUNDER (ARG) stalked the pace into the backstretch the final time, then tired. SCOTTISH COAST chased the pace along the hedge, slipped through inside GONDORF racing into the clubhouse turn to vie for the lead, contested the pace with that rival into the final turn, then faltered. TRUST THE DEPUTY stalked the pace for six furlongs and faded.
