ALEJANDRO away well, got clear in the first run, taken in hand, vied through the second turn along the inside, dueled into the stretch, edged steadily away the final furlong in a determined effort. GIMMEAWINKPOPPY rank into the first turn, came in to soundly bump CHISELED LIGHT, was taken outside to be four wide onto the backstretch and into the far turn, lost some ground to the winner, set down for the drive, closed some ground late. FOLLOWING A STEWARDS' INQUIRY AND A CLAIM OF FOUL BY THE TRAINER OF CHISELED LIGHT AGAINST GIMMEAWINKPOPPY FOR INTERFERENCE INTO THE FIRST TURN, GIMMIEAWINKPOPPY WAS DISQUALIFIED AND PLACED FOURTH. SAILING CLEAR chased the winner early off the inside, moved up to duel with that rival into and through the far turn, could not match strides with that same rival when straightened for home, caught late for the second spot. CHISELED LIGHT bumped soundly into the first turn, checked up and brushed the rail, recovered to race behind the first flight while along the inside, roused far turn, staged a mild rally while continuing inside. SWEETSOUTHERNMAN last away, void of speed, failed to menace. RUNNING WILDCAT pressed the issue in the three path for six furlongs then gave way in the drive.
