Footnotes

DISSENSION forwardly placed along the inside early, in some traffic out of the turn, came off the rail for room, engaged the leader with less than a furlong remaining, wore that rival down under firm handling. VALVERDINA took control soon after the start, set the pace, cleared to the inside, remained under confident handling into the lane, gave ground grudgingly to the winner. GLACKEN ROAD forwardly placed early, came in with five furlongs to run causing DON'TCALLMECHARLEY to clip heels, fell back a bit into the lane, mild late interest to catch that same foe late for the third spot. FOLLOWING A CLAIM OF FOUL BY THE RIDER OF DON'TCALLMECHARLEY AGAINST GLACKEN ROAD FOR INTERFERENCE UP THE BACKSTRETCH, THE LATTER WAS DISQUALIFIED AND PLACED FOURTH. DON'TCALLMECHARLEY forwardly placed, clipped heels when GLACKEN ROAD came over. moved up four wide in the turn, flattened out in the late going. BLACK HEIR in some traffic early, fell back, displayed a modest amount of late interest while not a serious threat. ARIEL'S FLYER off the early pace, lacked a late bid. SILVER SANDLES raced wide while never a threat.
