### Footnotes

CZECH MASTER took over leaving the chute, set all the pace while in hand, was given a breather in the turn, remained well clear down the lane under steady handling. WILLIE'S WAY a bit fractious in the gate, raced forwardly behind the winner and between rivals into the turn, could do little with that rival in the drive, held sway for the place. ACT OF DEFIANCE broke out and steadied slightly, fell back off the pace under restraint, moved closer while between rivals late in the turn, lacked a further bid and finished up evenly to prove best of the rest. TOP BUSINESS within striking distance on the outside, lacked a winning response in the drive. RED ZONE FLYER off a touch slow, raced back, bothered slightly between rivals midway on the turn, trailed into the stretch, steered out to be widest for the drive, improved position. THREEHIVES was never a serious threat while racing off the inside. VANISHING BUCK lacked speed, moved out to be four wide through the turn, managed little in the way of a rally. CONGRATS CRIMINAL forwardly placed early along the inside, began a steady retreat before three furlongs.
