Footnotes

PISTORIA close from the start, allowed the leader to go in the run up the backstretch, took over into the stretch, set down for the drive, maintained daylight to the wire under firm handling. TAPIT TO ME slow to settle in the first turn when well off the pace, advanced through traffic in the second turn, rallied on the outside in the drive and finished willingly to be up for the place. PARASOL settled in the second flight, came three wide into the stretch, could not get to her entymate, outfinished for the place. DELPHINUS in the second group early inside, fell back the middle half mile, raced in some traffic into the lane, staged a mild rally when clear the final furlong. SMOKIN ALI broke very awkwardly when detained at the start, raced back, altered course when along the inside nearing the furlong grounds, improved position a bit. MAGICPAGE vied up front early closest to the inside, checked when in tight midway on the first turn, fell back, recovered and quickly moved up to take over, soon clear, gave way when headed upper stretch. NASHIRA a bit wide into the first turn when well off the pace, was never a serious threat. STARSHIP PRINCESS broke well, raced with the pace while between foes, came in slightly to tighten up MAGICPAGE, fell back off the pace, evenly paced through the second turn, dropped inside for the drive, came up empty. SAY GRACE moved out soon after the start, got out to be very wide into the first turn, advanced on the outside in the run up the backstretch, got out again late in the second turn to be

extremely wide into the stretch, fell back. CRIOLLA LINDA dwelt after being detained at the start, raced far back and was never close. FOLLOWING A STEWARDS' INQUIRY REGARDING THE START, IT WAS DETERMINED THAT NEITHER SMOKIN ALI NOR CRIOLLOA LINDA RECEIVED FAIR STARTS AND EACH WAS DECLARED A NON STARTER.
