RONNIES ANSWER, allowed to settle, steadied on the turn, rallied outside to gain command at the sixteenth pole and edged clear under a vigorous hand ride. TOCAR set the pace under pressure and held on well for the place. SWEEPING HOURS chased the pace and weakened. APPEALING STORM, reserved and saving ground, was no threat after being steadied on the turn. TILLIE'S SWEEP prompted the pace and faded. COUNTRY JUDITH failed to rally.
