HUMOR ME DOC got clear soon after the start, rated while being pressured up the backstretch along the inside, headed turning for home, long drive, battled back in game fashion late to narrowly prevail. L. G.'S FLASH prompted the pace off the inside, moved to engage the winner from the outside late in the final turn, narrowly showed the way past the furlong marker, outfinished, clearly second best. DECAF AGAIN bobbled at the start, allowed to settle while saving all the ground early, moved out to overtake a tiring front runner in the second turn, slow gain the in the drive to finish up best of the rest. I GO THROUGH last to leave, fell far back, displayed a modest amount of late interest while not a serious threat. TIZAWONDERFULLIFE fell back after a quarter while racing outside, no threat. WELL READ reluctant to load, four wide in the first turn, failed to rally. INCLUDE TRACI pressured the winner early,moved up to vie with that rival before a half, stopped far turn.
