MY SNOOKIE'S BOY unhurried early, swung out for the stretch run and rallied under pressure to be up in time. BROTHER SCOTT rated off the pace, raced three wide on the turn, rallied to take over in the stretch and opened a clear lead but couldn't resist the winner in the closing yards. SQUIRE PHILIP outrun early, passed tired rivals for the show. DENIM DANCER chased the pace into the stretch and tired. SAGAMORE failed to menace. FORT KNOX raced in striking position around the turn and faltered. MR. WINALOT showed speed along the inside into the stretch and faded.
