Footnotes

PICATA tracked the pace, angled outside the leader on the turn, rallied to gain command nearing the eighth pole and drew off under pressure. SIERRA BELLA showed speed along the inside into the stretch, then was no match for the winner. CRYSTAL POND outrun after bobbling at the start, swung out for the stretch run and closed to gain the show while no threat to the top ones. HEAVEN'S REPLY broke slowly, then was steadied along the inside racing down the backstretch and failed to be a factor. LITTLEBITOFME showed brief speed and tired. TASHA'S EMBLEM chased the pace three wide around the turn, then faltered. GOLDBROOK was caught in tight early, saved ground around the turn, faded and was eased in the final eighth.
